#### **Strong Inflow of Tenants**

Hacienda Business Park in Pleasanton is reporting a strong, net positive inflow of tenants for 2012. Nearly 573,000 sf of development activity occurred in Hacienda during 2012, which includes new project approvals and construction. Net tenant absorption totaled approximately 210,283 square feet.

"This marks the second consecutive year of strong, positive growth in Hacienda. Our ability to attract quality tenants, such as those we saw arriving in 2012, is a continued demonstration of Hacienda's underlying value" said James Paxson, Hacienda's general manager. "Furthermore, we are seeing signs that 2013 will also be another year for positive absorption."

#### Swalwell Co-Sponsors Legislation

Congressman Eric Swalwell (D-CA) co-sponsored H.R. 11, the Violence Against Women Act Reauthorization Act, introduced yesterday by Congresswoman Gwen Moore (D-WI). This bill is essentially the same as the reauthorization that passed the Senate last Congress on a bipartisan basis, but was not considered by the House.

Swalwell, stated, "Thanks to the landmark 1994 Violence Against Women Act (VAWA), we have made great strides in protecting women from domestic violence and sexual assault, but there is much work left to do. That's why it was so frustrating that the bipartisan reauthorization of VAWA passed by the Senate was not considered by the House last Congress."

This new full access interchange connecting State Route 84 to I-580 improves mobility, reduces congestion, and provides local roadway, utility, and drainage infrastructure improvements in the western area of the City of Livermore. Special design considerations were provided in the design for the future BART extension to Livermore, protecting the environmentally sensitive Arroyo Los Positas and providing for the movements of endangered species under Portola Avenue. This \$100 million project was delivered in three construction packages resulting in an overall construction cost savings of twenty percent.
