Hacienda Adds Businesses

Showing the strength of the local economy, Hacienda Business Park in Pleasanton reports absorption of over 100,000 square feet of space in the first two quarters of 2011. The park is the largest mixed-use development in Northern California.

"We've seen strong activity during the first six months of the year and commercial brokers are reporting additional activity as well," said James Paxson, Hacienda's general manager. "From our perspective, these are all positive signs that Hacienda continues to be an important business address."

Major leases in 2011 have been initiated by companies in a variety of business segments, including Omron Network Products (fiber optics), IntegenX (DNA-related laboratory equipment), Pure Red Creative (advertising), and MetLife Home Loan (finance).

Over 10 million square feet of existing, mixed-use space is occupied by some 475 companies that locally employ approximately 17,500 people.

The current overall vacancy rate is 21%. The highest vacancy rate hit offices at 27%; research and development 10% and retail 8 percent. The types of businesses moving in represent a change from 2006, when research and development facilities had a 20 percent vacancy rate; offices, 9 percent; and retail, 2 percent. There was an overall vacancy rate of 10 percent. In 2010, the overall vacancy was 22%, with offices at 29 percent, research and development, 11 percent and retail, 4 percent.

No More Analysis Required

The U.S. Department of Energy/National Nuclear Security Administration /Livermore Site Office has determined that no Supplement Analysis of the 2005 Final Site-Wide Environmental Impact Statement for Continued Operation of LawrenceLivermore National Laboratory is required.

In a statement issued by the office, Livermore Site Office Manager Alice Williams, declared, "Based on the results of the Supplement Analysis, including an extensive review of comments submitted by the public, we have determined that the ongoing operations and new and modified projects and modifications in site operations at the Laboratory do not constitute a substantial change in the actions previously analyzed. There are no significant new circumstances or information relevant to environmental concerns. Therefore, no further National Environmental Policy Act documentation is required and the 2005 document remains adequate for the next five years."

The Supplement Analysis examined changes in programs, projects, or operations since the 2005 Site-Wide Environmental Impact Statement, new and modified plans, projects, and operations for the period now to 2015, as well as new information that was not available for consideration when the 2005 document was prepared.
